Notes for the Applicants

1. Fees

Adventure-Ship Ltd. is a non-profit making charity, which offers subsidized trips to youth organizations, to enable young people who would not be able to afford the full cost of hiring the JC Huan, to participate in our programs. Organizations making bookings must pass on the benefits of this subsidy and not gain any profit by charging participants more than their individual share of the cost incurred.

Any group found to be overcharging its members / participants will be prohibited from making future bookings and will be required to pay the difference between the subsidized and unsubsidized fees.

All participants must be the members, students, service recipients or staff of the organization which apply for the sea training program. Any group found to apply for service on behalf of other organizations will be prohibited from making future bookings and will be required to pay the difference between the subsidized and unsubsidized fees.

2. Sponsorship

Each year a certain amount of sponsorship is available to underprivileged groups who are unable to afford even the subsidized rates that we charge.

Agency / Group leaders who sincerely believe that their members are unable to afford even the subsidized rates may apply for further sponsorship by contacting our office at 2554-9722 to obtain a "Sponsorship Request Form". The sponsorship granted will depend on the amount of funds available. A site visit may be conducted to assess the genuine need of the organization.

3. Capacity

Participants of the training program must be over the age of nine at the time aboard the ship. The maximum capacity of our training vessel for both day and over-night trip is 60 persons. For disabled groups, the maximum number of disabled person should not be more than 25 people. The voyage will not be started if the capacity is exceed without prior approval.

4. Program

The sea trip will be cancelled when typhoon signal No.3 or above, black or red rainstorm signal is being hoisted, or other serious bad weather conditions occur, in the opinion of Adventure-Ship Ltd. or its authorized staff. No refund will be made if the voyage is cancelled by the participating organization or if the trip is affected by bad weather and has to be cancelled after it has started.

5. Insurance

Adventure-Ship Ltd. has public liability coverage. We will not be held liable for any damage or injury which may happen to the participants in the course of the training program if the accident is not caused by the negligence of our instructors and subject to the insured risks. Participants may arrange for their own personal accident insurance if they find necessary.
